4. Sealed bids must be delivered to **DOGDAKEDAR RURAL Municipality, Office Of The Municipal Executive Deulek, Baitadi,** before **12:00 Noon 2076/07/02** . Bids shall be valid for a period of 90 days after the deadline of bid submission. All bids must be accompanied by a bid security of amount mentioned below, **valid 30 days beyond Bid validity.** If bidder wish to submit Bid Security in the form of cash, the cash should be deposited in:

6. If the last day for purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
7. Bank Guarantee issued by any finance company in any form will not be accepted.
8. Bids should comply in all respects with the Instructions to Bidder included in the Bid Document.Non compliance with this instructions will result in disqualification.
9. In the case of discrepancies or error in bid documents, bid notice or any other documents, **Dogadakedar Rural Municipality Deulek, Baitadi** reserves the right to amend and correct at any time.
10. If bidders are not manufacturer, they must submit sole authorization letter from the manufacturer or from the authorized distributor of the manufacturer.
11. The supplier shall provide a Bid security Minimum 3% of the contract price in NRS issued by "A" class commercial bank located in Nepal, and shall be valid at least 30 days beyond the warranty period.
